Permit fee is calculated by multiplying the square footage of each Type of Improvement by the Permit Cost per SF. These figures are added to the base fee of \$70.00. The base fee is not refundable.

- ** Item #2-MOBILE HOME UNIT SITE: When item is used for sewer excavations in a new park, the permit application should include the application fee plus the number of unit sites. When setting a mobile home in a park or a mobile or modular home on private property, a permit should include the application fee, a sewer or building drain, and a water service or water distribution pipe.
- *** Item #3 FIXTURES, FLOOR DRAINS, SPECIAL DRAINS, WATER CONNECTED APPLIANCES INCLUDE **But Not** LIMITED TO: Water Closets, Sinks, Slop Sink, Drinking Fountain, Floor drain, Water Outlets, Bathtub, Emergency Eye Wash, Bidet, Condensate Drain, Roof Drain, Lavatories, Emergency Shower, Cuspidor, Washing Machine, Grease, Starch or Plaster Traps, Connections to Irrigation Systems, Shower Stalls, Laundry Tray, Urinal, Autopsy, Garbage Grinder, Dishwasher, Refrigerator, Water Heater, Water Softener, Any Water Connected Appliance
- **** Item #4-DOMESTIC WATER TREATMENT AND FILTERING EQUIPMENT: A license is not required for the installation of domestic water treatment and filtering equipment that requires modification to an existing cold water distribution supply and associated water piping in buildings if a permit is secured, required inspections performed, and the installation complies with the applicable code. The permit application shall include the application fee, the number of water treatment devices recorded in item #4 @ \$5.00 each and the appropriate water distribution pipe (system) size fee.

Base Fees include one inspection. When covering walls at least two inspections are required; rough-in and final.
