## MESSAGE FROM THE CITY MANAGER

## CITY DEPARTMENT SPOTLIGHT – POLICE DEPARTMENT

As the Chief of Police, I appreciate the opportunity to write to the community and give an update on the police department. Most of the time, my staff meets the community at times of struggle, disaster, mistakes, or emergencies. We will not limit our agency to only protecting and serving our community. We do so much more. My goal as a chief is to help Fremont thrive as one of the best communities in our area and to support the success of those living and spending time in Fremont.



Every day, the Fremont Police Department strives to provide and restore dignity to everyone in Fremont. We give dignity to people at every opportunity and try to restore dignity to those who become victims of crime or are impacted by mental illness, substance use disorder, crime, traffic crashes, or require assistance. Guiding our work are the constitutional principles we as a community cherish, Federal and State law, as well as the moral compass each staff member uses to guide our service to Fremont. Using the metaphor of the compass is appropriate because it guides our decision-making, leadership, ethics, and the personal growth of members.

Sharing our philosophy with Fremont is intended to give a "behind the curtain" view of our operations in the community we serve. While we prioritize privacy, confidentiality, and protecting the rights of crime victims, we often do not share the challenges we face as a police department. We hope everyone understands and does not discount what we are trying to contribute to our community. However, in 2025, we published our second annual report, detailing our crime statistics, programs, and a 21st Century Policing Report, which further details our operations and shows transparency. I encourage all to read these reports on our website for a better understanding of our operations.

Fremont is still a safe and vibrant place to live, work, worship, and spend time with your family. Like any city, the issue is those experiencing an increase in crime, disorder, and various community problems like untreated mental illness and substance use disorder. As our community ages, my staff often interacts with our older population experiencing mobility issues, cognitive decline, chronic disease, and social isolation. Frankly, the list of challenges seems endless on some days, as I call each of my officers and support staff to stay connected to the privilege and responsibility of helping those in need.

The Fremont Police Department is a community policing agency that aims to address each of these community issues individually or through collaborative efforts with local service providers. Policing and serving are not isolated entities in Fremont. We are part of the community, with a vested interest in everyone's success. As an agency and as your Chief, I look forward to working with you well into the future.

## FIREWORKS LAWS

Fireworks sold within the state are now allowed to be much louder and can leave the ground. Public Act 256 of 2011 legalizes consumer fireworks, such as bottle rockets and Roman candles. Before the rule changes, Michigan's firework laws were relatively restrictive. The only fireworks allowed for legal use were novelty fireworks that did not leave the ground or explode, such as sparklers or smoke bombs.

### Consumer Fireworks are regulated as follows per MCL 28.462:

- A person shall not ignite, discharge, or use consumer fireworks on public property, school property, church property, or the property of another person without that organization or person's express permission to use those fireworks on those premises. This includes roads and sidewalks.
- Consumer fireworks shall not be sold to a minor.
- An individual shall not use consumer fireworks or low-impact fireworks while under the influence of alcoholic liquor or controlled substances.

### When fireworks can be used is regulated per MCL 28.457:

A local unit of government may enact an ordinance regulating the ignition, discharge, and use of consumer fireworks, including, but not limited to, an ordinance prescribing the hours of the day or night during which a person may ignite, discharge, or use consumer fireworks. Suppose a local unit of government enacts an ordinance under this subsection. In that case, the ordinance shall not regulate the ignition, discharge, or use of consumer fireworks on the following days after 11 a.m.:

- December 31 until 1 a.m. on January 1.
- The Saturday and Sunday immediately preceding Memorial Day until 11:45 p.m. on each of those days.
- June 29 to July 4 until 11:45 p.m. on each of those days.
- July 5, if that date is a Friday or Saturday, until 11:45 p.m.
- The Saturday and Sunday immediately preceding Labor Day until 11:45 p.m. on each of those days.

The City of Fremont's local ordinance prohibits disturbing the peace. No one shall disturb public peace through loud, boisterous, or vulgar behavior, or by producing excessive, unnecessary, or unusually loud noise, whether on public or private property. They also cannot allow others under their control or direction to do so if it disrupts the peace, order, health, or safety of others, a neighborhood, or the community as a whole. We encourage residents to enjoy themselves responsibly and be considerate of their neighbors.

Additionally, the State of Michigan warns that when fire-related incidents involving consumer, low-impact, or illegal fireworks cause property damage, injury, or death, individuals may face misdemeanor or felony charges, with penalties of up to five years in prison and fines of up to \$10,000, or both.

## BURNING ORDINANCE WITHIN CITY LIMITS

Section 4.1 (D): Public or private bonfires in which material would exceed three (3) feet in diameter require a permit issued by the City Clerk and are subject to prior approval of the City Fire Department. Such approval may be granted at the sole discretion of the Clerk and Fire Department based upon:

- i. The proximity of the proposed bonfire to dwellings, trees and other structures.
- ii. Facilities available for fire management.
- iii. Atmospheric conditions.
- iv. Type of material to be burned.
- v. Any other consideration judged by the Clerk or Fire Department to be required to ensure safe burning.

## JASON BEST PROMOTED TO FIRE CHIEF

On May 1st, Jason Best was promoted to Fire Chief. Jason grew up in Grand Haven and moved up to Fremont in 2000. Jason and his wife said, "they could not think of a better place to raise our family." He has 3 children Colton (22), Rylee (20) and Morgan(19) that he is very proud of. In his spare time, he enjoys working on their horse farm, hunting, spending time in the mountains, horseback riding and camping.

Jason started his Firefighting career in Grand Haven with Grand Haven Township Fire Dept. When he moved up to Fremont for work, he joined Fremont Fire in 2001. Jason is a full-time Paramedic/Supervisor for Life EMS here in Fremont. Jason had held the rank of Captain here at Fremont since 2005 in charge of Medical and Rescue. He is currently certified and licensed as a Paramedic, Paramedic Instructor Coordinator, Fire Instructor, Company Officer 1&2, along with many smaller certificates.



Jason said this about his promotion to Chief, "I am excited about my new role as Chief to see where I can bring the department. Being a part-time paid dept (meaning all our firefighters have full-time jobs) brings unique challenges as our training requirements are the same as a full-time department. We need to keep things fun while trying to maintaining a safe amount of personnel that are committed to the time it takes to obtain and remain a firefighter. We will remain one of the best fire departments in the area."



## FIREFIGHTER CAPTAIN RETIRES AFTER 33 YEARS OF SERVICE

On June 30, Captain Ed Cook hung up his helmet and gear for the last time after 33 years. Ed began his firefighting career in 1992 where he quickly rose in the ranks to Lieutenant in 1996 and then to Captain and Training Officer in 1997. Over the years, Ed received the Michigan State Police Distinguished Citizen Award, multiple CPR and Hurst Life Saving Awards, and was named Firefighter of the Year in 2012.

Ed had this to say while reflecting on his time with the department, "This has been a life-changing career that I will never forget. I have met so many people who share the same passion for service, and I am grateful for every one of them. The fire service is a world of constant change and challenge — and I've found that being a lifelong learner is not just a philosophy, it's a necessity. My advice to those who remain is simple: always be a student of the craft. Pass on what you know. Leave the job better than you found it.

As I retire, what I'm most proud of is the opportunity I had to share my experiences and knowledge with others. Watching former cadets grow into firefighters, officers, and even chiefs — that's the legacy I leave behind. Thank you for the honor of serving this department and this community.

And of course, I can't forget the unique perspective that comes from spending so many years looking at life through a fire engine windshield. There's nothing quite like the mix of adrenaline, focus, and occasional windshield wiper malfunction as you're racing to help someone in need. You see the world differently from that seat — a little louder, a little faster, and a whole lot more meaningful."

## FREMONT FIRE DEPARTMENT IS HIRING! FIRE FIGHTERS AND MEDICAL FIRST RESPONDERS



The Fremont Fire Department is accepting applications for paid on-call firefighters and medical first responders. The Department has well trained firemen who provide training. You don't have to be both; you can be a fire fighter or a medical first responder!

Applicants must be 18, have a valid driver's license, and live within 5-miles of the City limits. Applications for either position can be picked up at city hall. If you have any questions, please call the Fremont Fire Department at **231-924-2103**.

## CHICKEN REGULATIONS IN THE CITY

The City of Fremont has had an Ordinance prohibiting chickens in town since 1972 and recently amended the ordinance last summer to permit chickens under certain conditions. Since chickens are considered a "barnyard" animal, the conditions/regulations will help maintain a buffer between someone's chicken coop and the neighboring residential dwellings. New regulating language in the City Ordinance Chapter 3 "Animals and Fowl" is as follows:

"An owner or occupant of a parcel of property ½ acre or greater may keep a maximum combination of four (4) hen chickens and/or rabbits within a fenced enclosure in the rear yard no closer than 125 feet from any adjacent dwelling place structure and comply with zoning regulations. Roosters are prohibited."



The Zoning Ordinance considers chicken coops an "accessory structure" and regulates size and location within a resident's backyard. Questions regarding coops can be addressed by City Zoning Officer Andy Harrington.

The City has been receiving complaints of chickens being raised and housed in various neighborhoods, so please make sure you are in compliance to avoid a \$90 civil infraction.



## PROPERTY TAX PAYMENT SCHEDULE

The City sends out property tax bills semi-annually. Summer taxes were mailed June 30th and are due by August 10th. A 4% late penalty will be added to any unpaid taxes on August 11th. Summer taxes include millages for the Fremont Public Schools (both operating & debt levies), State Education, City, County-Operating and the Fremont Community Recreation Authority.

Winter taxes are mailed on November 26th and due by February 14th. A 4% late penalty is added to any unpaid taxes on February 15th. Winter taxes include millages for Newaygo County specials, the Intermediated School District and the Fremont Area District Library.

For the convenience of our taxpayers, payments (check only, no cash please) may be placed in the drop box at the northwest exit of the City Hall parking lot at any time. Payments can also be made by credit card or E-Check from our website at [www.fremontmi.gov](http://www.fremontmi.gov). The City accepts tax payments until February 28th. Thereafter, all payments must be made at the County Treasurer's Office, P.O. Box 885, White Cloud, MI 49349.

### PARKING RV'S & TRAILERS IN THE STREETS

The City ordinance regulates the parking of recreational vehicles and trailers in the street public right of ways (ROW.) Most street public ROW's include 100% of the street and area between the sidewalks and curbing on each side of the street. If a sidewalk is not present, then the ROW area typically extends 15' from the curb into the yard.

Campers and trailers not connected to a vehicle cannot be parked in the street or the parkway between the curb and sidewalk. While disconnected they are not only a safety hazard, but unappealing to the neighborhood. Residents should be aware that parking of "unlicensed" vehicles, recreational vehicles and trailers is also not permitted in public right of ways or front yards.

### 2025 CONSTRUCTION PROJECTS

Every year, the City strives to maintain and improve its streets and water/sewer utility systems. During that time, residents and drivers experience inconvenient detours and construction noise, but the results of every project are always worthwhile. We thank residents for their patience!

#### Projects expected to be completed during the 2025 construction season:

##### Street Milling & Resurfacing:

- M-82 (Stewart/Main Street): MDOT to finish re-milling of entire M-82 highway between 56th Street and Green Avenue in town
- Connie Avenue: between Main Street & Lake Drive
- Weaver Avenue: between Hemlock & 44th Street
- Hemlock Street: between Stone & Weaver Avenue
- Gerber Avenue: between Main & Cedar Streets
- Oak Street: between Gerber & Reunion Avenue
- Sullivan Avenue: between Maple & Sheridan Streets
- Elm Street: between Darling & Decker Avenues
- Dayton Street: Weaver Avenue to Gerber Entrance
- Maple Street: between Weaver & Sullivan Avenues
- Southwoods: between Main & Oak Streets
- Gibson: between State & Main Streets
- Mechanic Avenue: between Woodrow & Apple Streets

##### New Construction:

- Branstrom Warming Lodge: construct new warming lodge center in Branstrom Park by ice rink/sledding hill
- Michigan Street Extension: finish construction of the extension of Michigan Street between Weaver & Division Avenues and the new Orchard Avenue to support the new 15-unit housing development







## FREMONT'S LATE SUMMER ANNUAL COMMUNITY YARD SALE

The late summer date is scheduled for August 7th – 9th, 2025, and the deadline to sign up for being on the list is July 30th.

To participate, all you have to do is call or come into the Fremont City Office, give us your name, address and phone number, and you're on the list! You can sign up for all 3 days, or just 1 day. City Offices are open Monday thru Thursday, 8:00 a.m. to 5:00 p.m. and Friday, 8:00 a.m. to 12 noon. If you have any questions, please feel free to call us at 924-2101.

Except for the City's coordinated community yard sales, the City will be enforcing its' regulations on garage sale signs this summer. While many are thankful the City is doing so; others do not appreciate the effort. The regulations are being enforced because 1) the Michigan Department of Transportation (MDOT) does not allow signs in their right-of-way, and many of the signs are placed along Main Street and Stewart Avenue in the MDOT right-of-way; 2) for safety reasons, signs should not be attached to utility poles; and 3) the signs are unattractive and often the signs are not taken down after the sale. Everyone has worked hard to keep Fremont looking neat, clean and beautiful for all to enjoy, so ridding the City of unnecessary signs is part of that effort.

## CITY COUNCIL WELCOMED THE CITY OF WHITEHALL

Representatives from the City of Fremont have participated in an annual Mayors Association of Michigan event, now referred to as "Community Exchange". This opportunity allows two communities to visit each other's city/village, visit with local municipal officials, and spend the day touring the respective community. The City of Fremont has participated in this event since the late 1980s, most recently, May of 2025, with a return visit to the City of Whitehall, originally visited almost 20 years ago.

In addition to sharing the attributes of each community, this occurrence offers each community not only an opportunity to observe each other's success stories but also allows the hosting community to review its asset base and share its story(ies) for a familiar audience. During this year, eleven officials from Whitehall spent the day in Fremont and six from Fremont returned to Whitehall for a visit.



Scheduling the 'must-see' parts of Fremont is always a bit of a dilemma, choosing pieces that best represent the 'whole' of the Fremont community, allowing for some 'downtime' is required. We have the Dogwood Center for the Performing Arts to provide that time for our annual guests. Guests and local representatives were welcomed by CEO Shelly Kasprzycki and staff members while hearing about the impact of the Foundation's community investments. In addition to the Foundation, the rest of the day was spent touring City Hall, the Fremont Area District Library, Fremont Arts Place, Chamber of Commerce, Trillium Springs, Stone Lodge and Tamarac. A driving tour of greater Fremont included visits to several of the City's parks, the airport, and the wastewater plant. Touring ended at Branstrom Park, site of the soon-to-be constructed warming lodge, adjacent to the existing Branstrom lodge building. Dinner was held at the Lakes restaurant; following an excellent meal, we returned to City Hall and said farewell to our guests.

Fremont representatives returned to Whitehall a couple of weeks later and were shown around their wonderful lakeside community, also enjoying an outstanding lunch at the Whitehall Playhouse, a vintage theater renovated over the last several years. Touring the Whitehall community was a pleasure; the City had arranged for a 'trolley car' to move us from site to site!
