

Fremont Community Joint Zoning Ordinance – Did You Know?

In a residential district, no more than twenty-five percent (25%) of the front yard may be used for parking, including driveways. Vehicles may not be parked or stored upon any lawn or landscaped area within the front yard. Regulations such as this, help keep neighborhoods looking attractive and maintained.

Fremont Adopt-A-Block Program

Over the past few years the City of Fremont has focused on improving its residential neighborhoods and assisting the residents that live in these neighborhoods. During the month of August, the City was pleased to facilitate the 3rd Annual Fremont Adopt-a-Block Program. The program has made a significant impact within these neighborhoods and 2015 proved to be another success.

For those unfamiliar with the program, Adopt-a-Block seeks to help residents make physical improvements to their homes and yards. Letters are sent out to all property owners on selected blocks inviting them to submit an application to request property improvement work to be done. Church groups and service organizations then voluntarily perform the work to be done on the properties. No matter the task at hand, the volunteers are grateful to assist their neighbors in tackling any sort of project needed.

This year the following organizations volunteered their time and participated in the Fremont Adopt-a-Block Program and helped to improve four properties:

- First Baptist Church
- Fremont Lions Club
- Reeman Christian Reformed Church

These groups, along with the home owners themselves, spent numerous hours power washing, landscaping, painting, staining, pulling weeds, and swinging sludge hammers to name a few activities. The result of the hard work by these community members is simply outstanding. It's amazing to see how a few helping hands can make such a difference within our residential neighborhoods.

Thank you to all who volunteered their time this past August. The hours you put in and the work you performed went a long way and is very much appreciated. Fremont Fire Department Ratings Upgraded



The City of Fremont Fire Department recently underwent a thorough Public Protection Classification "PPC" analysis of the structural fire suppression delivery system provided to the Fremont community and we are pleased to announce the Department has been upgraded from a "6" to a "5"! (the lower the number, the better...)

Although each insurance company independently determines the premiums it charges its policyholders, the PPC program plays an important role in the underwriting process. Fremont's Fire District includes the following jurisdictions: City of Fremont and the Townships of Sheridan, Dayton, Sherman, Garfield and Bridgeton. When updating your home insurance policy, be sure to note that Fremont's PPC rating improved to a 5 in July 2015, it may save you some money.

A big thanks to Fire Chief Brian Hettinger in his research and efforts during the review process and to the entire Fremont Fire Department for their life-saving efforts, improving response times and making it a great fire department for the Fremont community!

Halloween Trick-Or-Treating

- Chaperone your children and restrict activities to your own neighborhood
- Limit the age groups to pre-teen or younger
- Eye holes in masks should be large enough to easily see through them
- Wear reflective bright colors and use a flashlight so drivers can see you after dark
- Walk on sidewalks where available, or as near the curb as possible where no sidewalks are present
- Inspect all treats before allowing children to eat them

The Fremont Fire Department will be passing out treats between 6 and 8 p.m. at the Fire Station, so come enjoy the community atmosphere and share Halloween with our local heroes.

Take Pride in Your Curbside!

The City sweeps the streets every spring and fall, but weeds begin to creep up in the cracks by mid-summer. The City does not spray for weeds along the curbs in late summer, so residents are asked to help maintain areas where curbsides and sidewalks become overgrown.

Our Deadhead Committee, a group of citizens that volunteer their time to de-weed downtown flowerbeds and parking lots, encourage residents to “take pride in your curbside!” Weeds are commonly removed by weed-killer products, pulled while the soil is damp or by a weed-whip. Residents and their lawn-care providers should blow cut grass back onto the lawn while mowing or with a blower to avoid grass and weed seedlings from filling the seams in the curbing and sidewalks.

A lot of time and energy is spent by residents keeping their yard and surrounding area tidy and pleasant, so we encourage everyone to join them in their efforts and take pride.

Fremont’s Yard of the Month Award Program

The Fremont Yard of the Month Award Program was initiated to recognize the hard work exhibited by Fremont residents who take time and effort to beautify their yard. This type of effort has a positive overall impact on the City and makes Fremont a better place to live. The

Voter ID Reminder

Voters will be asked to provide identification when they visit the polls on Election Day. They will be asked to present a valid photo ID, such as a Michigan driver's license, federal or state government issued photo I.D., passport, military identification card, student identification or tribal identification card.

Anyone who does not have an acceptable form of photo ID or failed to bring it with them to the polls may still be able to vote. They will be required to sign a brief affidavit stating that they're not in possession of photo ID. Their ballots will be included with all others and counted on Election Day.

Flushing of Fire Hydrants

The City Water Department will be conducting the semi-annual **Watermain Flushing Program** on Friday evening, **October 2nd**. Flushing will continue throughout the evening until finished. Some discoloration of water may occur throughout Saturday, so let your water run for a short period until clear. While the water will continue to be safe to drink, residents are urged not to do light colored laundry during this time.



Winter Parking Restrictions

The City reminds motorists that there is no parking of any motor vehicle upon any public street or alley within the City limits between the hours of 2 AM and 6 AM at any time from December 1st thru April 1st. Your cooperation would be greatly appreciated.




Refuse/Recycling Changes



During the first two weeks of January and July each year, property owner may elect to change refuse pick-up service from a roll-out cart to mixed-refuse bags or vice-versa by notifying the City Offices. Please note that changes are only allowed during these two-week periods.

BRUSH CHIPPING IS COMING TO AN END

The City continues to remove brush without charge, the first Monday of each month April through October. The last brush pick up for the 2015 season will be the first Monday in October (10/5). Brush must be stacked with the cut end at curbside with limbs no more than three inches (3") in diameter. The City will not remove remaining tree-top brush from a tree removed by either the owner or a private tree removal company. The program is intended for routine tree/bush trimming and fallen branches. Residents throughout the City must have their brush placed curbside by 7:30 a.m. of each first Monday morning. Brush is not to be placed at curbside any earlier than the Friday before the first Monday. The City will also continue to provide curbside chipping of Christmas trees the first two weeks of January.

NEW FREMONT DOG PARK DEVELOPMENT

The Fremont City Council recently authorized development of a new Dog Park in Fremont. Establishing a dog park in Fremont so residents can walk or drive their dogs to the park, unleash them in a fenced in area to run and exercise and will be a benefit to residents. Fremont Dog Park Committee members conveyed the importance of owners and their pets benefiting from both exercise and socialization, noting this would be another great amenity to the Fremont park system.

With inclusion of two \$5,000 grants (City & FAF), \$14,700 has been raised, but the Committee still needs to raise additional funding to complete the park. The Park will have two separate fenced in areas, one for large dogs and one for small dogs. Adding amenities like benches and dog-related obstacles would also be dependent on fundraising efforts. The goal is to have the Park open this fall.

Donations are being accepted at the Fremont City Offices and checks should be made out to "City of Fremont" with "Fremont Dog Park" in the memo line. Questions regarding the Fremont Dog Park may also be directed to the City Offices at 231-924-2101.



Winter 2015 Property Tax Payment Schedule

Winter taxes will be mailed on Monday, November 30, 2015 and due by Wednesday, February 17, 2016. A 4% penalty is added to any unpaid tax bills. Winter taxes include millage rates for Newaygo County, Intermediate School District, Fremont Area District Library and on occasion, a County Drain.

Taxes can now be paid online by credit card or e-check at www.cityoffremont.net (see "CREDIT CARDS ACCEPTED AT CITY" section in this newsletter for more details).

*The City can now accept partial payments.

For the convenience of our taxpayers, payments (by check only) may be placed in the drop box at the northwest exit of the City Hall parking lot. The City accepts taxes payments until Saturday, February 29, 2016; on March 1, 2016 all payments must be paid to the Newaygo County Treasurer's Office at PO Box 885, White Cloud, MI 49349.

City residents are reminded that, per City Code, election signs are not to be placed in the City street rights-of-way. They may not be placed, nailed or affixed to any tree, utility pole, light, sign or lamp post or other object within the area between the curb and sidewalk along all City streets. Non-conforming signs will be removed without notice or compensation.

The Newaygo County Clerk's Office will again provide election results through the Internet site at www.electionmagic.com. Current election results, as they are reported to the County Clerk's Office, will be posted on election night. Upcoming 2015 election dates to remember:

☑ **October 5, 2015:** Last day to register for voting eligibility for the November 3rd City Election.

☑ **November 3, 2015:** City General Election, 101 E. Main Street, Fremont. Polls open at 7 AM and close at 8 PM.

As a convenience to our City voters, if you or your spouse would like to be added to the City's permanent absentee voter (AV) list, please stop by the City Offices with proof of identity, and you will be added to the list. Those on the list are mailed an AV application before each election as a reminder and given the option to vote absentee or in person. Please exercise your right to vote at all elections. We should all live by the adage that "If you don't vote, you don't have the right to complain!" ★

for protecting natural resources such as rivers, wetlands, groundwater, farmland, and open space.

A Comprehensive Plan is a long-range policy plan for land use that helps guide officials when making development decisions. The updated Plan includes text, charts, tables, graphs, illustrations and maps that describe the Joint Planning Commission's proposal for the long-range development of the community.

The public may appear at the public hearing in person or by counsel. All interested persons will be afforded an opportunity to be heard. The hearing will provide for the fullest opportunity for expression of opinion. The Fremont Community Joint Planning Commission will receive and consider communications in writing with reference hereto. Written communication may be provided to the Fremont Zoning Administrator for consideration up to the time of the hearing.

Please watch for upcoming announcement of the public hearing dates this October thru December for review of the draft plan, revisions and adoption.
